MOTION, submitted by Vice Mayor Mann, WE move that the City Administration begin the process, including drafting of legislation, for special assessment of certain residents of Mulberry Street to build a public retaining wall that prevents further landslide activity from adversely affecting residences and the public right-of-way(see attached petition). The assessment process should accomplish, without limitation, the following: 1. Demonstrate the replacement of the failing Peete Street private retaining wall will serve a public purpose including through testimony to be provided at the Neighborhood Committee; 2. Provide for design and construction of the wall along with necessary sewer connections; 3. Access benefitted property owners for the cost of the wall over a period of not less than 30 years; 4. The City will assume not less than 1/50th of the cost of the wall as required by law; 5. Provide for the acquisition of easement rights for the City for the planned wall and City maintenance of the wall going forward; and 6. Provide an opportunity for property owners to comment at a public hearing on the final cost estimate and wall design prior to resolving to move forward with the assessment.
