Attached for your submission to Council is an emergency ordinance captioned as follows:

AMENDING Section 203-33 of the Cincinnati Municipal Code, “Service Retirement Allowance; Vesting”, in order to modify the existing procedure applicable to City employees who have outstanding City retirement loans, and who are eligible to apply for deferred retirement with the Cincinnati Retirement System, by providing more flexibility regarding repayment of the retirement loans while still resulting in full loan repayment to the Cincinnati Retirement System.

An Ordinance No. _____ - 2008

AMENDING Section 203-33 of the Cincinnati Municipal Code, "Service Retirement Allowance; Vesting", in order to modify the existing procedure applicable to City employees who have outstanding City retirement loans, and who are eligible to apply for deferred retirement with the Cincinnati Retirement System, by providing more flexibility regarding repayment of the retirement loans while still resulting in full loan repayment to the Cincinnati Retirement System.

WHEREAS, Cincinnati Municipal Code ("CMC") Section 203-33 currently requires that, with regard to deferred retirements, any City employee who has a retirement loan outstanding with the Cincinnati Retirement System ("CRS") at the time of leaving City service is required to pay back the loan in full prior to reaching age 60 or within one year of leaving City service, whichever comes first; and

WHEREAS, at its September 5, 2008 meeting, the Board of Trustees of the Cincinnati Retirement System approved a motion which, if thereafter enacted by Council ordinance, would amend the existing CRS procedure to allow a deferred retiree to maintain his or her outstanding retirement loan until the effective date of the deferred retirement, which would provide future City retirees with more flexibility regarding repayment of retirement loans while still resulting in full loan repayment to the Cincinnati Retirement System; and

WHEREAS, under the proposed amended procedure, the outstanding retirement loan would be paid in full, including all interest, by CRS payroll deduction over a period not to exceed two years from the effective date of the deferred retirement, regardless of the individual's age at the time of attaining deferred retirement status, unless the deferral period would exceed ten years; and

WHEREAS, if the period of deferral will exceed ten years, the outstanding loan will be required to be paid in full, including all accrued interest, prior to the effective date of the start of deferred retirement payments, which will eliminate the possibility of the loan balance plus interest exceeding the member's contribution balance; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Section 203-33 of the Cincinnati Municipal Code, "Service Retirement Allowance; Vesting", be amended as follows:

Sec. 203-33. Service Retirement Allowance; Vesting.

(a) Any member may be entitled to a service retirement allowance, as provided herein, after reaching age 60 with 5 years of creditable service or with 30 years of creditable service regardless of age. The 5 years of creditable service required for a service retirement allowance after reaching age 60 shall only apply to persons who enroll or re-enroll in the retirement system on or after January 1, 1969.

A member having completed 5 years of creditable service on or after January 1, 1989, or in the case of a member who serves at the pleasure of the appointing authority, after completion of 5 years of creditable service on or after January 1, 1989, shall be entitled upon reaching age 60 to a service retirement allowance; provided, however, that the entire accumulated contributions of the member remain to the member's credit in the retirement system.

If said member has a retirement loan outstanding at the time of leaving service, the loan **** 1 **** shall be paid in full, including all accrued interest, by payroll deduction over a period not to exceed two years from the deferred retirement benefit effective date. However, if the period of deferral will exceed 10 years after leaving City service, the loan shall be paid in full, including all accrued interest, prior to the benefit effective date of the deferred retirement. If the loan **** 2 **** is not repaid as stipulated herein, the following options exist:

(i) the member can have the balance of contributions refunded directly as specified in Section 203-57;

(ii) the member can have the balance of contributions rolled over into another qualifying plan, including the Public Employees Retirement System as specified in Section 203-59;

(iii) a member having at least 25 years of service and being at least age 55, can take a reduced retirement as specified in Section 203-35. Application for deferred retirement shall be made before the member leaves the service or within one year thereafter, except application may be made after said one year with the approval of the board of trustees.

(b) The service retirement allowance described in this subsection (b) shall apply for:

(e) In no event shall the service retirement allowance provided herein be greater than 90% of the average highest compensation for those members retiring after April 1, 1993. Average highest compensation, for those retiring on or after April 14, 1999, shall be calculated or recalculated in accordance with the provisions of Section 203-1-A3 contained herein, notwithstanding the provisions of Section 203-1-A3 contained in Ordinance No. 264-2000.

(f) In no event shall the service retirement allowance provided herein, exceed the limit established by Section 415 of the "Internal Revenue Code of 1986," 100 Stat. 2085, 26 USCA 15, as amended.

(g) An employee whose service retirement allowance would be calculated as described in subsection (c) shall be permitted to make an election to have his or her service retirement allowance calculated as described subsection (b) if, according to the terms of the Fair Labor Standards Act (FLSA), the employee moves from the non-exempt status of being eligible for FLSA overtime pay, to the exempt status of not being eligible for FLSA overtime pay. Any such employee shall have 60 days from such change in FLSA status to make the election. Such election shall be irrevocable once made, regardless of future changes to the employee's FLSA status. An employee who elects to have his or her service retirement allowance based on the pension calculation formula described in division (b) herein, shall have his or her with "average highest compensation" calculated in accordance with the corresponding provisions of Section 203-1-A3(a).

(h) For purposes of this Section, a member's State Retirement System Benefit Percentage shall be the percentage multiplier that was in effect under the terms of the State Retirement System to determine the pension or other retirement allowance of the member under that system for each separate year of service credit that is being transferred to this Retirement System.

The member's State Retirement System Benefit Percentage shall be determined using the percentage multiplier that was in effect for the calculation of the member's pension or other retirement allowance on of the last date that member was in the employment of an employer covered by the relevant State Retirement System. Accordingly, and not by way of limitation, increases in the benefit multiplier of a State Retirement System shall not be taken into account for purposes of determining a member's State Retirement System Benefit Percentage if such increases became effective after the date that the member ceased to be employed by an employer under the relevant State Retirement System.

By way of example, a member's
Benefit Percentage can be currently located in
Revised Code:

- (a) PERS - Section 2201
- (b) STRS - Section 2202
- (c) SERS - Section 2203
- (d) PFPF - Section 2204
- (e) HPRS - Section 2205

If a member previously worked
under a State Retirement System, the
Benefit Percentage shall be determined by
the State Retirement System at the time of
termination of employment.

Prior to the passage of Ordinance No. 77-1998 and Ordinance No.130-1999, members who retired on or after January 1, 1976, were entitled to 2 percent of the average highest compensation, including overtime pay, compensatory pay and other lump sum distributions, as more specifically described in Ordinance No. 63-1976 and Ordinance No. 545-1983.]

Section 2. That existing Section 203-33 is hereby repealed.

Section 3. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter be effective immediately. The reason for the emergency is the immediate need to provide greater flexibility regarding loan repayments, especially in light of current difficult economic circumstances.
