WHEREAS, Principal has been issued a certificate of competency pursuant to Section 401-41 of the code of Ordinances of the City of Cincinnati permitting him to extend, repair, and alter water service branches and install water meters in any premise served by the Greater Cincinnati Water Works for a period of up to (1) one year from \_\_\_\_\_ to **December 31, 20\_\_**, inclusive; and

WHEREAS, Section 401-41 of the Code of Ordinances provides that before any certificate of competency is issued to any person such person shall furnish to the Superintendent of the Greater Cincinnati a bond in the sum of one thousand dollars (\$1,000.00) indemnifying the City of Cincinnati from any loss it might suffer through the fault of the person to be certified, or his agents or employees, in installing any water service branch or meter; therefore,

If Principal, including his agents and employees, performs all work for which a certificate of competency is required under Chapter 401 of the Code of Ordinances of the City of Cincinnati in accordance with the Ordinances of the City of Cincinnati and the rules and regulations of the Greater Cincinnati Water Works, repair or correct any defective work done or any damage done to the Greater Cincinnati Water Works System, and any other water system for the maintenance of which shall be void, otherwise it shall be and remain in full force and effect; the undersigned agreeing and consenting that this undertaking shall be for the benefit of the City of Cincinnati and any other party sustaining any loss by reason of principal, his agents or employees, failure to properly install, alter, repair or connect water service branches or water supply lines, operate a curb cock or install water meters in accordance with the ordinances of the City of Cincinnati and

the rules and regulations of the Superintendent of the Greater Cincinnati Water Works during the period of his bond and that either the obligee herein or any such party or both may bring action on this bond.
