Dear Cincinnati Property Owner:

Please take notice that on March 30, 2022, Cincinnati City Council passed Resolution No. **42-2022** declaring the necessity of, and an assessment for, the planting, care, maintenance, trimming, and removal of public trees in and along the streets and the public right-of-way within the City of Cincinnati's Urban Forestry Maintenance District for the year 2023. This assessment provides the City with funding necessary to conduct 24-7 emergency response for downed trees in the right of way, a six-year preventative maintenance cycle, routine stump grinding, replacement of all trees removed, and systematic planting to improve tree canopy in the highest areas of need throughout the city.

Our records indicate that you are the owner of Hamilton County Auditor parcel number(s) **(1420004000100)** and that the assessment for said parcel(s) is over \$500.00. To access a copy of Resolution No. 42-2022, the Urban Forestry Program's fiscal year 2024 work plan, and the proposed budget, please visit the office of the Clerk of Council, Room 308, City Hall, 801 Plum Street, Cincinnati, Ohio between the hours of 8:00 AM and 5:00 PM, Monday through Friday.

The assessment shall be levied by the front foot method and shall be based on a rate of \$0.31 per foot abutting the right-of-way. The assessment will be included with your December 2022 tax bill, which will be sent to you by the Hamilton County Treasurer, payable to them with your property taxes. Please note, the City Treasurer will not accept payment of the estimated assessment or the actual assessment.

If you wish to object to the proposed assessment, please deliver a written response within 14 days of the date that you receive this letter to:
