AUCTION RULES

1. This sale will be held under authority of Section 4513.61 and 4513.62 of the Ohio Revised Code and Section 513-11 of the City of Cincinnati Code of Ordinances.
2. Auctioneer reserves the right to refuse service to anyone.
3. **All** auction participants must obtain a bid number. All auction participants must be at least 18 with valid identification. Only bidders who obtained a bid number will be recognized as potential bidders. Bid numbers are issued at the Police Impound office at 9:00 AM. You must have a bid number to enter the auction area.
4. **All sales are final. All cars are sold, As Is/Where Is, absolutely no warranties, no guarantees, expressed or implied. No exchanges, returns, or refunds. (BUYER BEWARE!)**
5. Terms of the sale are **CASH** or **CREDIT ONLY**, (card holder must be present with a valid photo ID) payable immediately after the sale.
6. Bidder is responsible to make their bidding intentions known to the auctioneer: audibly, visually, or both. Auctioneer is **NOT** responsible for bids not seen or heard.
7. The highest accepted bidder is the purchaser.
8. Successful bidders must remove all vehicles from the impound auction lot by 3:00 PM the Wednesday following the auction or storage fees will be assessed at \$25.00 (plus tax) per day, plus a onetime towing fee of \$19.32.9. Auctioneer requests bids be made from the area in front of the vehicle being auctioned.
10. If the Police Department received a key when the vehicle was impounded, the word **KEY** will be marked on the windshield. The Department makes **NO GURANTEE** the key functions.
11. If the auctioneer determines the opening bid does not meet the vehicle's value, they may reject the bid and withdraw the vehicle from the sale; and if having acknowledged an opening bid, they decide any advance thereafter is not enough, they may reject the advance.
12. All cars are sold with a **SALVAGE** unless told otherwise.
13. You have 15 days to transfer title, or there is a cash penalty.
14. Additional costs will be incurred when having a salvage titled vehicle inspected, registered, and licensed with the State of Ohio.
15. Theft offenses are punishable under O.R.C. 2913.02
