# **Complaint Summary:**

Mr. Charles Edward Stewart, reported that on August 30, 2020, at approximately 1:30 a.m. his vehicle, a red Hummer H3, was parked along Poplar Street when CPD officers, unjustifiably and without probable cause, entered his vehicle and caused it to be towed and impounded. Mr. Stewart further alleged that Officer Oscar Cyranek and other CPD officers routinely stop him when he is driving through his neighborhood. He further stated Officer Cyranek enters vehicles causing damage, improperly removes property, and seizes or removes vehicles in the downtown area of Poplar and John Streets without the legal right to do so.

# Analysis:

According to statements from Mr. Stewart, the officers and BWC viewed, near 1 a.m. on August 30, 2020, CPD officers entered and searched a locked red Hummer parked on Poplar Street. The officers gained entry into the vehicle without the permission or the presence of the vehicle's owner or occupants.

# Allegation 1: Improper Search & Seizure

Mr. Stewart alleged that the officers searched his vehicle violating his right to privacy and his vehicle was towed without cause. CPD officers were assigned to patrol the area of Poplar and John in the department's effort to increase police visibility in high crime areas. BWC footage showed the officers, in execution of this duty, peering into vehicles which were parked along the street. When the officers peered into Mr. Stewart's vehicle they noticed a firearm in the rear passenger console of the vehicle, a marijuana cigarette on the front area of the vehicle and what appeared to be an open container of alcohol. The BWC footage also showed officers, using tools, entered the vehicle and retrieved the items viewed. Further search of the vehicle revealed a knapsack containing several Ziplock bags filled with marijuana in the vicinity of the recovered firearm.

Mr. Stewart's vehicle was parked along a public roadway and the interior of the vehicle could be viewed by any passerby. There can be no expectation of the right to privacy in this circumstance. The Fourth Amendment allows the warrantless seizure of evidence in plain view, even though the discovery of the evidence was not inadvertent (e.g., police patrolling a high crime area looking for evidence of crime). The discovery of the firearm and marijuana in plain view gave rise to the search the vehicle. Mr. Stewart's vehicle was also parked illegally and per City Ordinance could be towed. CCA has concluded the Officers were within CPD's policy, procedure, and training.

## Allegation 2: Harassment

In his statement to CCA, Mr. Stewart alleged that there were three officers on Poplar and John Streets when his vehicle was entered, searched, and towed. Of the three officers, he recognized one of them to be Officer Oscar Cyranek. Mr. Stewart further alleged that "because of the type of vehicle I drive, they [police] are always harassing me". He claimed that he is stopped by different CPD officers to include Officer Cyranek, every time he drives through his Westside neighborhood. The officers stop him but do not give a reason for stopping him. Mr. Stewart also stated he has been stopped two times in 2020 prior to this current incident.

A search of CPD's RMS did not reveal any stops of Mr. Stewart or his vehicle, prior to August 30, 2020. Based on the footage from the BWC, before reaching Mr. Stewart's vehicle, the officers can be seen peering into other vehicles on Poplar Street. Mr. Stewart was not present during the search of his vehicle.

There is no evidence to impute knowledge of vehicle ownership to the officers. Further checks revealed that Officer Cyranek was not present on Poplar at the time of the incident. There is no evidence of to support Mr. Stewart's claim of harassment. CCA has concluded that the allegation of harassment is unfounded.

#### Allegation 3: Discrimination

Mr. Stewart alleged that one of these officers, Officer Oscar Cyranek, was known to him before and had previously stopped him on a different occasion. Mr. Stewart insinuated that Officer Cyranek stopped him because he is a black male driving a nice vehicle.

CPD Procedure Manual § 12.205 states, "[n]o law enforcement agency should condone or promote the use of any illegal profiling system in their enforcement program." CPD Manual of Rules and Regulations (in part) Failure of Good Behavior 1.23C prohibits any prejudice concerning race.

Article IV §4 A of the City's Municipal Code defines racial profiling as "the detention, interdiction or other disparate treatment of an individual using the racial or ethnic status of such individual as a factor, other than in the case of a physical description." The Ordinance makes such actions on the part of the police subject to disciplinary action or dismissal.

In his statement to CCA, Mr. Stewart stated that he was present on Poplar and John Streets on the night of August 30, 2020. However, Mr. Stewart was not identified in any of the BWC footage. Of the men spoken to by the officers on the night of the incident none identified himself as Mr. Stewart or the owner of the red Hummer. It cannot be made out that any of the CPD officers on Poplar and John Streets on the night of August 30, 2020, profiled Mr. Stewart. The officer identified by Mr. Stewart as Officer Cyranek was also not present at the scene. CCA has concluded that the allegation of discrimination is unfounded.
