**Meeting of the Cincinnati Elections Commission
Minutes of July 9, 2026**

CEC members present: Marucs Bethay, Andria Carter, and Ligaya West.

City representatives present: Ian Doig, Law; Teninnah Ross, Law

Administrative:

1. Welcome to new CEC Member – Ms. Andria Carter

The CEC Commission welcomed Ms. Carter. Ms. Carter noted that she is a former employee of the Urban Leage and a volunteer in the neighborhood.

2. Resignation of Mr. Klingensmith

The CEC accepted the resignation of Mr. Klingensmith. The CEC appreciates his assistance over his time with the CEC. Ian noted that there is now an open spot and if anyone knows of anyone interested in serving, please pass that information along to him or the mayor's office.

Old Business:

3. Approval of the April 9, 2026 meeting minutes

A vote was taken and minutes were approved.

New Business:

4. Discussion: Overview of City Business List ("CBL") and Temporary Prohibition List ("TPL")

Ian opened discussion describing what the City Business List is and the Temporary Prohibition List. Ian shared Sec. 119-9 which covers the enforcement. This section provides the CEC with the right to receive and investigate any complaints alleging violations of Chapter 119. Any allegations may be referred to the ethics and good government counselor in the city solicitor's office for investigation. Ian added that this section is important.

Ian began to walk through the municode website. This site shows all the Charter and Municipal Codes for the City of Cincinnati. Chapter 119 is new and was added in October 2021. This was added to keep an eye on campaign contributions to active councilmembers or mayors. Section 119 only deals with active positions. Section 119-1-F focuses on the "Financially Interested person" which are people who are related to the company seeking business with the city. The code prevents those people from contributing to an active councilmember campaign while they are seeking business with the city under Section 119-1-C2.

Ian added the City Business List is available online. The Temporary Prohibition list shows active or pending items being placed in front of council. A financially interested person doing business with the City of Cincinnati may not make donations to a current active councilmember.

5. Discussion of the 2026 Post-Primary Filings (non-City candidates)

Ian updated the CEC on the recent 2026 Post-Primary Filings that were reviewed by him appear to have no flags. This means there were no overcontributions nor contributions that should not have been received.

6. Discussion: Recent Supreme Court ruling in National Republican Senatorial Committee v. Federal Election Commission

Ian opened the discussion explaining that this ruling is related to campaign finance. Ian provided a copy of the ruling to the CEC members. Ian shared that the ruling related to the coordinated expenditures from political parties. The court has held that a political party cannot be limited on what they spend on coordinated expenditures.

Ms. Carter thanked Ian for providing the information.
