Meeting of the Cincinnati Elections Commission

Minutes of November 13, 2025

CEC members present: Marcus Bethay, Nick Klingensmith, and Ligaya West.

CEC members excused: Sally Jo Krisel.

City representatives present: Ian Doig, Law; Teninnah Ross, Law.

Old Business:

1. Approval of the September 18, 2025 Meeting Minutes

Mr. Bethay moved for approval of the September 18, 2025 meeting minutes as provided. The motion was seconded by Mr. Klingensmith. A vote was taken and the minutes were approved unanimously.

New Business:

2. Overview of Charter Amendment and Campaign Finance Reporting Schedule

Mr. Doig provided an overview of the recently approved charter amendment aligning the City's campaign finance reporting deadlines with those of the State of Ohio. He explained that the amendment simplifies reporting requirements for candidates by synchronizing reporting periods and deadlines, including post-general, annual, and semi-annual filings. Mr. Doig reviewed anticipated filing deadlines for 2026, noting that while no local elections are expected, some committees may still be required to file reports. Commissioners discussed the anticipated reduction in reporting activity during the upcoming off-election year.

3. Extension of Deadline to Fill Commission Vacancy

Mr. Doig explained that the charter amendment also extended the timeline for appointing new members to the Commission and granted the Commission discretion to further extend that deadline. He noted that the current vacancy has exceeded the prior deadline and recommended establishing a new deadline to encourage timely appointment.

Motion: Mr. Bethay moved to extend the deadline for appointing a replacement Commissioner by forty-five (45) days from the date of the meeting. The motion was seconded by Mr. Klingensmith. A vote was taken and the motion passed unanimously.

4. Discussion of Upcoming Post-General Election Campaign Finance Reports

Mr. Doig reminded the Commission that post-general election campaign finance reports are due

on December 12, 2025, and that approximately thirty campaign filings are expected. He outlined the review process and invited Commissioners to participate in reviewing filings, noting the need to avoid triggering open meetings requirements. Ms. West expressed interest in participating in the review process.

5. December Meeting Schedule

Mr. Doig noted that the Commission's December meeting has been rescheduled as a special meeting on December 18, 2025 at 4:00 p.m. He explained that, as a special meeting, discussion will be limited to items listed in the meeting notice, including review of post-election campaign filings. Commissioners were invited to suggest additional agenda items for inclusion in the notice.

Other Business:

No additional business was brought before the Commission.

Adjournment:

With no further business to come before the Commission, the meeting was adjourned by unanimous consent.

Two Issues to Consider Today:



Is the filing complete and accurate, and does it contain no overcontributions?



Is the filing timely?

Duties of the Commission – Report Contents

- Charter Article XIII, Section 4(c):
 - Making a preliminary determination that a report filed with it is complete and accurate, and does not indicate any overcontributions
 - Immediate notice to a person alleged to have violated this Article
 - Holding a hearing that meets due process requirements for the alleged violator within 30 days of receipt of the notice
 - Sending to the alleged violator and the complainant within 30 days of the end of the hearing a written decision on the alleged violation.

Duties of the Commission – Report Contents

- Charter Article XIII, Section 4(d):
 - If the commission makes a preliminary determination that a report filed with it is incomplete, inaccurate, or contains an overcontribution it shall conditionally accept the report and by certified mail notify the filer of its determination.
 - Within 7 days of receipt of the notice, the filer may submit an addendum that corrects the deficiency or indicates the refund or return of an overcontribution. The commission may grant an extension to file the addendum. If the filer fails to submit an acceptable addendum, the commission shall conduct further proceedings in accordance with subsection c.

Duties of the Commission – Violations

- Charter Article XIII, Section 4(e): **Finding a violation.**

After finding a violation of this Article, the commission **may** impose a civil fine or other penalty authorized by this Article.

Duties of Commission – Timing of Reports

- Charter Article XIII, Section 2(a): A candidate ... that made or received a contribution or expenditure supporting a candidate for city council or mayor shall file with the commission ... a full, true, and itemized report of the contribution or expenditure in the manner and form required by the commission by not later than 4:00 p.m. on the following dates:
 2. The thirty-eighth day after the municipal general election [December 12, 2025] to reflect the contributions received and expenditures made from the close of business on the last day reflected in the last previously filed statement, if any, to the close of business on the seventh day before the filing of the statement [December 5, 2025].

Duties of the Commission – Penalties

- Charter Article XIII, Section 2(d): Penalties.

- 1. Contribution.** When the commission chooses to impose a penalty for making, soliciting, or accepting a contribution that exceeds the maximum permitted by this section, the penalty shall be a civil fine equal to three times the excess contribution.
- 2. Reporting.** The penalty for failure to file a report required by this section is a civil fine for each day of violation a) in a council election, \$100, and b) in a mayoral election, \$200.

Suggested Language for Motions:

- If there **are no issues** identified with a report:

“I move that the Commission, having identified no overcontributions or other issues, accept the reports of _____ as complete and accurate.”

- If there **are issues** identified with the reports:

“I move that the Commission...

Overcontributions: “...conditionally accept the reports of _____ and notify their campaign to address any potential inaccuracies and overcontributions within __ days.”





Timeliness: “...assess a penalty in the amount of \$_____ in connection with the late filing of _____’s reports.”
