RE: West End Mixed-use Development | Community Engagement and Inclusion Efforts

Since March 2022, FCC representatives have attended West End Community Council (WECC) and FCC Community Coalition meetings and provided updates on the development. Formal presentations have been underway this year to WECC and FCC Community Coalition. Presentations to the OTR Community Council and an open-to-the public input session took place in July 2023.

In many discussions with community leaders, we found a strong desire to have a destination district that will attract visitors and offer much-needed amenities that residents desire and deserve. Residents asked that the plaza and other public spaces are accessible to people of all ages and abilities. Much of the community feedback received was focused on the desire of



neighborhood residents to have entertainment and dining options other neighborhoods have. One resident remarked that there is no restaurant to take his wife out for an anniversary dinner. Residents want the district to be of a high quality and modern design. They also mentioned on several occasion that they want to the buildings to be tall and that the design team should "go big!"

## Summary of the Community Benefits Agreement

A Community Benefits Agreement was jointly negotiated and signed by the West End Community Council, FC Cincinnati and The Port in 2018. The agreement identified community priorities to improve the quality of life in the West End. The 30-year agreement is valued at more than \$50 million. Community Benefits Agreement commitments include:

- Meet stadium construction inclusion goals of 25% MBE, 7% WBE and 30% SBE. FC Cincinnati
  and our project team of Turner Construction and Jostin Construction <u>exceeded</u> these goals
  with 25.52% MBE, 14.7% WBE and 30.49% SBE with a total spend of \$180.7 million with
  minority-and women-owned companies and small business enterprises.
- Create and operate a youth soccer program in the West End. The West End Pride boys and girls teams were created in 2018 and now include 11 teams with 237 players. The program is free to any youth who live in or have ties to the West End.
- Build mini-pitches (youth-sized soccer fields) in the West End and other needy communities. Eight mini-pitches have been built with a ninth opening on August 29.
- Operate soccer instruction during gym classes in West End schools and after school at the Lincoln Rec Center and Lindner Y in the West End.
- Contribute at least \$100,000 annually to non-profits working in the West End or located in the West End.
- Support a construction training program and First Source job referral program to increase local hiring for stadium construction jobs.
- Meet regularly with the West End Community Coalition. FCC also formed and met regularly with a Design Committee of West End residents to gain input on the stadium design.
- Commission a Traffic Study prior to stadium construction to minimize impact of the new stadium to the neighborhood.
- Pay its full-time hourly employees at least \$15 per hour.
- Host job fairs in the West End.
- Prioritize the West End community organizations and schools for concession sales fundraising, other fundraising opportunities, and volunteer opportunities during MLS games at TQL Stadium.
- Adopt preference for West End suppliers and vendors and a supplier inclusion plan.
- FCC has also contributed:
  - \$200,000 for affordable housing development in the West End
  - \$100,000 to a West End Emergency Housing Fund
  - \$150,000 for a West End housing study and community outreach



- o \$20,000 to MORTAR for entrepreneurship support in the West End
- \$250,000 to create a Social Justice Fund supporting local organizations with a track record of addressing racial inequities in the region, \$100,000 of which directly benefited West End non-profit organizations.
- Hundreds of FCC staff and player volunteer hours per year with West End organizations
