Purpose: The purpose of this meeting is to present information about each proposed project and

collect public input and feedback on the proposals and allocation of funds.

Project Locations: 6 and 12 Elder Street, 34 Green Street, 1710-1712 Race Street, 1715 and 1800-1810

Republic Street, and 1724-1734, 1801-1809, and 1811 Vine Street

Project Summaries:

Crossroads Health Center: The project would renovate the southern building at 1715 Republic for the new Crossroads Health Center and create 108 public parking spaces on 34 Green, 1710-1712 Race, and the northern portion of 1715 Republic. The City Funding Request is up to \$4.4 MM from tax increment financing (TIF) funds.

Findlay Flats: The project would renovate ten buildings at the corner of Elder and Vine, including 6 and 12 Elder, 1724-1734 and 1801-1809 Vine, and 1801-1810 Republic. All properties are vacant and would create seven new street-level commercial spaces and 45 new residential rental units, 15 of which will be affordable housing for individuals earning 80% or less of the Area Median Income. The City Funding Request is up to \$6.7 MM from tax increment financing (TIF) funds.

Findlay Community Center: The project would construct a new Community Center at 1811 Vine to replace the OTR Recreation Center that is currently located one block south at 1715 Republic. The facility will consist of a two-story building totaling 65,000 square feet. The center will provide recreation and wellness services, including a gymnasium, running track, indoor pool, fitness center, roller rink, childcare center, multi-purpose rooms, administrative space, rooftop outdoor fitness space, and play areas. The City Funding Request is up to \$22.0 MM from tax increment financing (TIF) funds.
