- **August 7, 2023:** Kingsley + Co. meeting with owners of 2630 Euclid Ave at 9:30 AM.
- **August 8, 2023:** Kingsley + Co. presentation to the Corryville Community Council general body.

- **November 20, 2024:** Kingsley + Co. received a letter of support from Corryville Community Council to rezone the property to a PD.
- **January 7, 2025:** Kingsley + Co. participated in the Department of City Planning & Engagement's Virtual Public Staff Conference on January 7, 2024 to gather additional community feedback on the development.
- **January 10, 2025:** Kingsley + Co. and Taft Law meeting with Dan Schimberg/Uptown Properties to discuss the Euclid development and address parking concerns.
- **January 13, 2025:** Kingsley + Co. presentation of the Euclid development at the Mt. Auburn Community Council January Board meeting.
- **January 21, 2025:** Kingsley + Co. presentation of the Euclid development at the Mt. Auburn Community Council General Body meeting.
- **January 28, 2025:** Kingsley + Co. submitted a revised Concept Plan and Program Development Statement to the City, increasing:
 - Vehicle parking spaces to approximately 214 (from 173), resulting in an approximate ratio of 1.19 spaces per unit.
 - Bicycle parking spaces to approximately 203 (from 182).
