We're excited you've chosen to take a tour of the Greater Cincinnati Water Works (GCWW) Richard Miller Treatment Plant (RMTP)!

Your tour will include the following:

- The GCWW Water History Museum, which details the progression of providing the region with safe water for 200+ years.
- The facilities used to process, treat, and clean the water including sand filtration, Granular Activated Carbon (GAC), and Ultraviolet Disinfection (UV).
- The state-of-the-art lab facilities and testing processes that ensure the safety of the water.
- An explanation of how water from the Ohio River is treated to produce safe drinking water.
- An understanding of how water is delivered to the people who live in the region... from source to tap!

Directions

RMTP is located at 5651 Kellogg Avenue, Cincinnati, OH 45230.

1. From I-275, take Kellogg Avenue Exit 72 and follow the signs for S.R. 52/Kellogg Avenue West.
2. Go approximately 1 mile.
3. Turn left into the GCWW main entrance and check in with the guard located at the entry gate.
4. Be sure to have all photo IDs ready.

Arrival

- Please arrive 10 minutes early.
- Tour begins promptly at 9:30 a.m.



Requirements

Waiver

All participants 18 and older [must complete a waiver](#).

Photo ID

This is a secure and active facility. Participants **must** have a photo ID to present at the guarded entrance gate (not required for children).

Attire

- Closed-toe and closed-heel shoes required. No sandals, flip-flops, or Croc-type shoes are permitted.
- Long pants are recommended (shorts are permitted when temperatures are high).
Please note: There is no AC or heat in some areas. Indoor temperatures average between 55°F (winter) and 85°F (summer).

Age

Children nine years and older are permitted on the tour. Adult supervision is required at all times for all children.



Accessibility

This is a walking tour with stairs and small obstacles. This is not an accessible facility; however, some parts of the tour can be accessed. Please advise us in advance if any of your party have mobility issues.



Safety

- Participants do **NOT** need hard hats or safety glasses.
- Please inform us ahead of time if anyone in your party has a fear of heights, confined spaces, easily becomes light-headed, or has vertigo.
- Smoking is **NOT** permitted inside the facility.



Photography/Videography Policies

- Photography is encouraged in the museum area; however, photography will be limited to specific places during the tour.
- Video or audiotaping during the tour is **NOT** permitted.



Personal Items

Handbags, backpacks, or briefcases are not encouraged on the tour. These items should be left in visitors' vehicles.



Food/Drink

Food and drinks will not be provided and are **NOT** permitted inside the facility.
